Agenda Item: Ordinance Repealing Ordinance No. 1071 And Annexing Certain Land Into The City Of Edgerton, Kansas

<u>Background/Description of Item</u>: On December 28, 2017, Edgerton City Council adopted Ordinance No. 1071 annexing seventeen (17) properties adjoining the City of Edgerton south of Interstate I-35 near Homestead Lane by consent annexation.

Subsequent to the passage and publication of Ordinance No. 1071 it was determined that multiple legal descriptions provided to the City of Edgerton for the seventeen annexed parcels did not properly describe the subject real properties. The City of Edgerton has requested and received revised Consents for Annexation for the seventeen tracts, including the corrected legal descriptions.

City Attorney is working with the property owners to prepare an ordinance to repeal Ordinance No. 1071 and annexing land into the City of Edgerton, Kansas with corrected legal descriptions.

Corrected Consent for Annexation Forms have been filed. As with the previous ordinance, all request for annexation is voluntary and is contiguous to property within the City of Edgerton corporate city limits. Enclosed is a map of the various property locations. The final ordinance will be distributed to City Council at the March 15, 2018 special city council meeting.
